

A number of internationally recognised centres enhance the research culture of the School:

#### The Human Rights Law Centre

is committed to the promotion and protection of human rights and the establishment and strengthening of the rule of law worldwide. It cooperates with students, professionals, governments, civil society and international organisations and has implemented programmes in Europe, Africa, Asia and the Middle East.

#### The Public Procurement Research

Group is a major global research centre which provides a focus for supporting research and teaching on public procurement within the School of Law, as well as promoting understanding of this subject on a wider basis by oganising conferences and workshops. It also provides training for lawyers and government officials from all over the world.

#### The Centre for Environmental

Law provides a nucleus for a range of initiatives reflecting expertise in environmental issues throughout the world, including publications and conferences.

The Treaty Centre conducts research into the law of treaties and the practice of treaty-making. Its principal activity to date has been the compilation of Multilateral Treaties: Index and Current Status, a comprehensive and pioneering research source for information on around 1,000 of the more significant multilateral conventions.

#### **Centre for English Language Education**

The Centre for English Language Education, CELE, has been providing English language support for international students at the University of Nottingham since 1987.

CELE runs an 8-week course, designed in collaboration with the School of Law exclusively for international postgraduate students going on to study Masters degrees in the field of law. International students can also take advantage of the Centre's language support service for postgraduate students whilst studying at the University.

#### **Computing facilities**

School of Law students have access to state of the art computing facilities, including the Baker & McKenzie Resource Room, a recently refurbished computer suite to which only School of Law students have access.

#### Library

The Hallward Library houses the Law Collection of approximately 60,000 books, law reports series, journals, pamphlets and microfilms. Students have unlimited access to extensive collections of primary and secondary legal materials via a wide range of electronic sources. The library is open long hours every day of the week and students have access to a knowledgeable staff and a dedicated law librarian.







## Graduate School

The Graduate School can be found in the University's landmark Trent Building. This School provides postgraduate students with their own dedicated centre, featuring space for studying and socialising, computer facilities and meeting and seminar rooms.

Nottingham is a prosperous, student-friendly city situated in the heart of the UK. ## Sport

## Sport at the University

The University has a state-of-the-art Sports Centre and an indoor eight-lane swimming pool on the University Park campus, as well as exceptionally good facilities for all outdoor sports. The Sports Centre provides resources for badminton, basketball, football, archery, martial arts, table tennis, dance and circuit training, to name but a few. Facilities also include a climbing wall, a modern, well-lit fitness centre, floodlit artificial sports surface, tennis courts, a bowling green and a sports injury clinic. Trinidad and Tobago LLM Environmental Law

Foundation of International Environmental Law and Development

I was a Legal Officer at the Environmental Management Authority of Trinidad and Tobago before deciding to take an LLM.

I chose Nottingham because it was ranked as one of the top universities in the UK and was one of the few that offered an environmental law course. I was very interested that it was a popular destination for international students as I wanted to meet people from different places and cultures. The beautiful campus was a big draw for me as I am a bit of a nature buff!

The course explored many of the international regimes which lie at the heart of the environmental laws enacted and currently being developed in my country and thus gave me an international perspective which enhanced the knowledge I had acquired as a result of my background.

What I learned on the LLM has been invaluable as it exposed me to extremely interesting and dynamic issues such as climate change and the international regime which is attempting to tackle it and has allowed me to take up an internship with FIELD, a dynamic international law chambers specialising in environmental issues.

## MA Socio-legal and Criminological Research

This programme is aimed primarily at those wishing to enhance their legal research skills before embarking on a doctorate and is one of only two such Economic & Social Research Council recognised programmes in the UK.

## MSc Law and Environmental Science

This interdisciplinary programme provides students with an opportunity to explore the interplay between scientific knowledge and the law.

## **Teaching and assessment**

The full-time programme is a 12-month course of full-time study.

Specifically designed for the Masters programmes, we offer a wide and diverse range of over 50 modules. You will find brief descriptions of each specialist LLM on the following pages and further details can be found on the School of Law website at <a href="http://www.nottingham.ac.uk/law">www.nottingham.ac.uk/law</a> The list of available courses and modules may change from time to time.

Students take the equivalent of four full-year modules during the taught element of the programme and then proceed to a researched dissertation.

To qualify for one of the specialist LLM degrees, the equivalent of three full year modules and the dissertation topic must come within the relevant specialism.

Teaching is normally by a weekly two-hour seminar in each module. Students are encouraged and expected to participate in seminars, which is a reflection of the interactive nature of the programme.

Assessment is by essay, examination or a combination of both.

Italy **LLM Human Rights Law** UN Assistance Mission in Afghanistan



Before starting the LLM I worked as pararalegal in the Commercial Department of Eversheds LLP. However, when offered the opportunity to complete my studies to qualify as a commercial lawyer, I decided instead to come to Nottingham and specialize in International Human Rights Law.

I chose Nottingham because of its international reputation and excellence in International Law and Human Rights Law. The LLM course gave me the knowledge and preparation necessary for analyzing complex human rights situations, and gave me the confidence to work in difficult field operations.

In January 2006 I came to Afghanistan and started working as Monitoring and Evaluation Assistant/Gender Officer for DACAAR (Danish Committee for Aid to Afghan Refugees). Since November 2006 I have been working as a Human Rights Officer in the Central Regional Office of the UN Assistance Mission in Afghanistan (UNAMA).

#### LLM Public International Law

Studying public international law at Nottingham in this challenging age of international politics provides those specialising in the subject with an excellent opportunity to appreciate how the law works and how it is applied in a range of different contexts.

This programme is designed to provide candidates with a sound knowledge of the law in the substantive fields of human rights, the environment and armed conflict, and introduces candidates to the complex array of problems and controversies which arise in these areas. Candidates gain an understanding of the contrasting differences and similarities between subdisciplines – from sources of law to interpretation, application, development and enforcement.

Candidates will keep abreast of current developments with respect to United Nations. Specific areas of substantive law (such as protection of refugees and minority rights) form an integral part of the human rights programme.

#### LLM Criminal Justice

Postgraduate criminal justice teaching in the School of Law is distinguished by its strength in the international, comparative and philosophical dimensions of criminal justice. In addition to the core teaching programme, postgraduate students are invited to the Criminal Justice Discussion Group which hosts distinguished visiting speakers. Modern criminal justice processes are subject to historic political developments, seemingly irresistible economic forces, world-wide cultural transformations, and rapid social change. The LLM in Criminal Justice encourages students to develop the intellectual skills, knowledge and understanding necessary for meeting the new challenges of crime and justice in the twenty-first century.

#### LLM International Criminal Justice & Armed Conflict

This unique masters degree enables postgraduate students to study advanced options relating to the international dimensions of criminal justice and the law and practice of international armed conflict. Emphasis is placed on contemporary problems and issues in the emerging, interdisciplinary field of International Criminal Justice, with attention to the theoretical significance, as well as to the practical challenges, of achieving criminal justice in the international arena. The School of Law's Human Rights Law Centre has active research links with the International Criminal Court and many LLM graduates have subsequently undertaken internships with international criminal tribunals or related human rights NGOs.

#### LLM Criminal Justice and Armed Conflict

My experience at the University of Nottingham more than met my expectations. In particular, I enjoyed learning from recognised experts who succeeded in communicating their enthusiasm for, and expertise in their fields. Certain courses were co-chaired by two or three lecturers. This allowed students to look at various possible approaches to a given legal issue, which proved to be extremely interesting. Coming from a university system where courses mostly take the form of lectures, I found the class discussions both challenging and stimulating. The fact that many students were overseas students also increased the interest of the debates. This was especially useful with regard to International Criminal Justice courses as this field of law involves comparative analyses of various legal systems.

#### LLM International Law & Development

The relationship between law and development has been a central concern of policy makers, lawyers and scholars throughout the last century. Since 1945 the international community and international organisations such as the World Bank, the IMF, and the WTO, have promoted economic development as an end in itself often turning to law to achieve this goal. In more recent years, while the language has changed to one of globalisation and good governance, the aim of development has remained central to the process. But what exactly does development mean and to what extent have the lives of billions of people improved?

#### LLM Environmental Law

Many of the problems which environmental law confronts require concerted action either globally or within a region of the world. The international law of the environment and EC environmental law are the focus of the options available under this degree.

Options cover a wide range of issues of contemporary relevance, from the conservation of wetlands to liability for nuclear damage. The underlying purpose is to provide a solid grounding in the basic principles of EC and international environmental law as applied in a particular context, whether that be ensuring the cleanliness of a local bathing beach or preserving the rain forest.

Without the time management and self-discipline skills that Nottingham installed I would not have been able to pass the New York Bar while working full-time in a law practice as a paralegal and Compliance Manager.

Nottingham taught me the importance of setting goals, developing plans and having the confidence to see projects through to finality. As a self supporting researcher, these skills are extremely important. I provide technical legal analysis on the research projects covering many diverse areas of law including contracts, constitutional, finance, tort, state, federal, international, transportation and environmental law.

#### LLM Maritime Law

The LLM Maritime Law is a product of the strength of the School of Law in three complementary areas: shipping, environmental and Public International Law. A high proportion of international trade is conducted by sea, involving annually in excess of four billion tonnes of cargo. The sea is not, however, merely a medium for transport. It harbours vast resources under the sea bed and in its waters.

The LLM Maritime Law embraces both private and public law and addresses aspects of the private law of shipping. It also embraces important public international law issues that are addressed at regional and global levels.

Before coming to Nottingham to study for the LLM International Commercial Law I worked as an Account Executive in an foreign invested company in China

I chose Nottingham because the School of Law offers the modules which I see as most valuable for my career: marine insurance, international sales of goods, carriage of goods by sea. It also helped that a school mate of mine in China who went to Nottingham the year before thoroughly enjoyed the course and the life there. He also told me that living in Nottingham is affordable compared to other big cities and that the campus is beautiful and peaceful. Of course, I followed his recommendation and I am delighted that I did.

#### LLM International Commercial Law

The LLM International Commercial Law enables candidates to study a wide range of commercial law options of international relevance. It embraces a number of related areas of commercial law, examining transactional and regulatory law. The public and private law of international trade and shipping law are well represented.

Intellectual property law and cognate subjects are extensively considered. Further significant strands to the degree are provided by options relating to banking and finance law, the conflict of laws (sometimes called private international law), and the law of public procurement.

#### LLM European Law

One of the most exciting legal developments of the postwar era is the dynamic evolution of a European legal system that is something more ambitious than traditional international law, but not, technically speaking, the law of a sovereign state. Specialising in European law demands an appreciation of the basic pattern of the law of the European Union, combined with the study of increasingly important sectors of European community legal developments, such as competition policy, social policy, environmental policy and consumer policy. European Law also embraces aspects of private international law and appreciation of human rights law.

#### MA Socio-legal and Criminological Research

This course is specially designed for students intending to progress to research careers or research degrees in socio-legal studies or criminology. The programme is recognised by the Economic & Social Research Council (ESRC) for its "1+3" postgraduate studentships competition, and the School of Law currently has three quota places on the programme, over 2006-2008, allocated by the ESRC.

The MA provides interdisciplinary training through core modules in qualitative and quantitative research methods, philosophy of social sciences, and legal research methods, augmented by optional subjects (including relevant LLM modules) pertinent to a particular candidate's substantive research interests.

Following my LLB in Nigeria and LLM from the University of Cambridge, I came to Nottingham to undertake my PhD entitled "A Centralised Collective Security System: The United Nations and Regional Organisations after the Cold War."

I decided to come to Nottingham because of the considerable expertise of its staff in Public Internaional Law, as well as the huge reputation of the School as a centre of excellence both in teaching and research. This course has been of huge benefit to me not merely in terms of my career development as an international lawyer, but also in terms of using international law to build particular expertise in peace and security.

I was fortunate to be awarded a scholarship for my studies and, in addition, I won other scholarships offered by the School that enabled me to attend several dedicated courses for master and doctoral students across Europe. These courses not only helped me to develop my understanding of international law as a subject, but also put me in touch with other international lawyers across the globe.

The research and intellectual culture at Nottingham, as well as the readiness and friendliness of staff and students alike, compete with the very best traditions anywhere. I feel very lucky to have studied in Nottingham and would recommend the School to anyone anytime.

## **Research degrees**

The School of Law strives to promote research excellence among all its scholars. It recognises that high-quality legal research may take many different forms. A wide variety of legal research methods are employed in the numerous research projects ongoing in the School.

The School of Law believes that postgraduate research students and academics are all engaged in the same scholarly endeavours and can learn a great deal from each other. Postgraduate research students are invited to play a full role in all the research activities of the School.

Whilst legal research is often an individual activity, many collaborative research activities, including co-authorship of publications, collaborations with visiting scholars, seminars, reading and discussion groups and distinguished visitors' seminars, take place in the School. Postgraduate research students are encouraged to participate in all such activities.

The School of Law offers supervision for research degrees in most subject areas of the law, and also for interdisciplinary projects which have a legal aspect. The School currently has about 40 registered graduate research candidates, who come from all over the world.

Research candidates may study either for the Degree of Master of Philosophy (MPhil) or for the Degree of Doctor of Philosophy (PhD). Those candidates wishing to study for a PhD are normally admitted first to the MPhil programme, and may then transfer to the PhD later if progress warrants this.

In line with the majority of law schools within the United Kingdom, the normal length of an MPhil thesis is about 60,000 words, and a doctoral thesis, about 100,000 words.

The School also offers the degree of Masters by Research (MRes). This flexible one-year full-time research degree offers the possibility to combine taught masters modules with a substantial piece of research.

### **Research facilities**

As well as benefiting from very extensive library holdings, research students in the School of Law enjoy a number of excellent facilities.


All research students currently registered in the School of Law have 24-hour access to a private study carrel, each with its own computer (wired for internet access) and lockable desk space. These carrels are located in the School of Law Research Student Rooms. The School of Law also has a generous fund to assist research students with expenses incurred in connection with their research work, such as field trips and attendance at conferences.

### **Skills development**

All research students undertake the School of Law's module, Legal Research Methods. This module considers the diverse spectrum of legal scholarship and methodologies. Students will refresh or enhance their legal research skills and receive training in a range of research methods and techniques. The School of Law also offers a wide range of courses on specific areas of law, and students are able to participate in the School's extensive undergraduate and postgraduate modules.

The School's annual Research Presentation Day affords students the opportunity not only to develop presentation skills that will be useful in their viva voce examinations, delivering conference papers and their future careers, but also to obtain feedback on their research work. The event is also useful for finding out more about the work that their colleagues are doing and provides an enjoyable social occasion.

In addition, the Graduate School provides a wide variety of training courses which students are encouraged to attend as appropriate. These cover general matters such as use of information technology for research and writing, time management, planning a thesis and preparing for the viva voce examination, as well as specialist topics such as use of statistics and qualitative research methods. Training on teaching methods is available as many research students are involved in teaching.



Before starting the PhD, I had obtained an LLM at the College of Europe, Bruges, then completed my training as a lawyer, qualifying to the Athens Bar. I worked as an intern for the European Commission.

I chose to study at the University of Nottingham because of the reputation of its Law Department and I was delighted to be offered a scholarship by the School. The PhD offered me sound knowledge of public procurement, a highly technical field of law.

I am currently a practising lawyer in one of the top law firms of Greece and use the technical knowledge acquired through the PhD to advise clients on public procurement matters.

I came to Nottingham to undertake the LLM International Commercial Law after an internship at the Commercial Court of Vienna.

I chose Nottingham because the University was very highly ranked with the British Council and the application procedure allowed for late applications. I decided only at a rather late stage to do an LLM prior to qualifying as a lawyer.

The course offered me a specialisation in Public Procurement Law, which is still one of my main areas of practice. Moreover, it offered me a great insight into common law. Coming from a civil law legal background, this helped me a lot to broaden my legal view and way of thinking.

The opportunity to meet fellow students from practically all over the world also needs mentioning. Equipped with the knowledge and social skills from Nottingham, I was able to do a PhD in Procurement Law and to become an attorney-at-law with one of the leading law firms in Vienna.

## How do I apply?

### LLM and MA programmes

Normally, you will possess (or be predicted to obtain) a degree in law or a related discipline (such as International Relations) of a first or good second class honours standard or the overseas equivalent. Allowance may be made for special qualifications, experience and background, and students with other academic backgrounds will be considered.

### **MSc programme**

Applicants for the MSc must hold a degree in law or a related discipline or a degree in physical, environmental or biological science, normally of a first or good second class honours standard or equivalent. Candidates without a first degree in science will be required to hold at least one A-level science qualification or its equivalent, preferably in physics or chemistry. A-level mathematics will also be an advantage. Allowance may be made for special qualifications, experience and background.

## **Research degrees programme**

Applicants to the Research Degrees Programme will normally be expected to have (or be predicted to obtain) a Masters degree in law or a related subject of a good standard. ## English language requirements

If your first language is not English and you do not have a degree from a UK institution, you will have to show evidence of your competence in English. We will normally require one of the following:

**Either** an IELTS score of at least 7.0 with a minimum score of 6.5 in each element

**Or** any one of the following TOEFL scores: *Paper* 600 with 5.0 in the Test of Written English *Computer* 250 with 5.0 in the Test of Written English *IBT* 100 with no less than 21 in any element
